Dear Committee Members:

As a mineral exploration company active in the industry in Nova Scotia we attended your session on Thursday 29 October 2009. We were disheartened to see that such an important issue and legislation is being directed by special interest groups opposed to mining and industrial development. Personal opinions and outdated misleading material seems to be the order of the day without regard for the science and engineering.

The professional environmentalists and the mining industry hosted a major conference on uranium mining and processing in Halifax this fall. This was an excellent opportunity for all sides of the issue to learn the latest facts from the top experts in the country. It was ignored by all but a few professionals. Government representation was dismal at best. Canada is a leader in the world in all aspects of the nuclear industry.

As a company we acquired exploration licenses excluding salt, potash, coal and uranium to enable us to evaluate strong mineralization models for lead – zinc - silver and tin - tungsten – molybdenum occurrences. Our models were enhanced by a release of details on a new lead – zinc – silver occurrence in granites south of Windsor by the Mines Branch in the fall of 2006. We encountered uranium mineralization in locations where we did not expect to find it and to a much more wide spread degree than anyone could anticipate. We pulled all our employees from the properties.

We immediately disclosed the information to the Mines Branch and guided Mines Branch representatives on a field trip to examine our work locations and the major occurrences of uranium. We have been awaiting instructions from the Mines Branch since the spring of 2008. At this point we will not conduct any exploration in the Province without specific direction from government. We have invested in excess of \$3,000,000 in Nova Scotia. Our exploration office is in Nova Scotia and we employ Nova Scotians.
